Submission of Petition

Dear Sirs,

Please find attached a petition of 867 signatures requesting that NWBC reconsiders its decision to close the toilet block in Station Road, Atherstone on the 1st April 2022.

I would like to ask that the petition be drawn to the attention of Cllor Caroline Symmonds (Chair of the Resources Board) reports the receipt of this petition to the meeting at the council Chamber on Monday 28th March. Also that the petition is published on the NWBC's website.

During the process of collecting the signatures in Atherstone town center it has become apparent that there is a definite need for this facility in particular by those people visiting the town on public transport together with the bus crews themselves.

We have also had many comments that the proposed alternative facilities in the leisure center and council offices are too far away when you have just spent 30-45 minutes on a bus and suffer from medical problems necessitating an urgent need to use the toilets.

Bus crew members have also highlighted that the toilets at the terminus are essential as they do not have time in their schedule to leave the bus and walk to the other facilities, which are often closed when they need them most in the early morning and evening shifts.

Finally, people signing the petition wish to see Atherstone marketed as a go to destination. The recent rises in fuel prices, cost of living and heating bills suggest more people will be shopping locally. It is also likely that more people will be using public transport and therefore the existing facility will be used more.

From the diversity of the postcodes of signatories on the petition it is clear that the town offers a good trading hub with people visiting from other towns quite some distance away including Leicestershire, Staffordshire, W. Midlands and Derbyshire.
