2. Notes and Matters Arising of the meeting held on 26th February 2015

Minutes were agreed. Matters Arising:

Market Street, Atherstone - there is no engineering solution. Cllr N Dirveiks would not be able to fund a feasibility study from Delegated budget where no capital project is possible. Cllr N Diveiks is working with enforcement officers to reinstate cobbles and york stone surfacing where needed.

A5 Mancetter traffic island – no update available

Church Road, Hartshill Bus Lay By and Bus Shelter

Cllr C Clark has set aside an extra £10K. Project value now £37K.

Hartshill Parish Council to be kept informed of progress.

Provisional costings sought from statutory undertakers to move/lower gas, sewers, telecom and electrical services that are all under the footpath.

PCSO S Mander presented Safer Neighbourhoods Team update. The following comments were made:

- SNT handheld speed gun being repaired
- Local HGV operators to be approached to reduce HGV traffic through Hartshill

- Request to Superintendent M Samuel to ask WCC to keep streetlights on in Friary Road following incidents of ASB
- WCC Highways to be encouraged to reinstate gating before summer holidays in Lewis Close jitty
- Sheepy Road carpark contractors temporary fencing needs removing
- Cllr Clark to set up residents meeting to review Margaret Road traffic scheme
- Speeding through Hartshill from Atherstone Road along Castle Road
