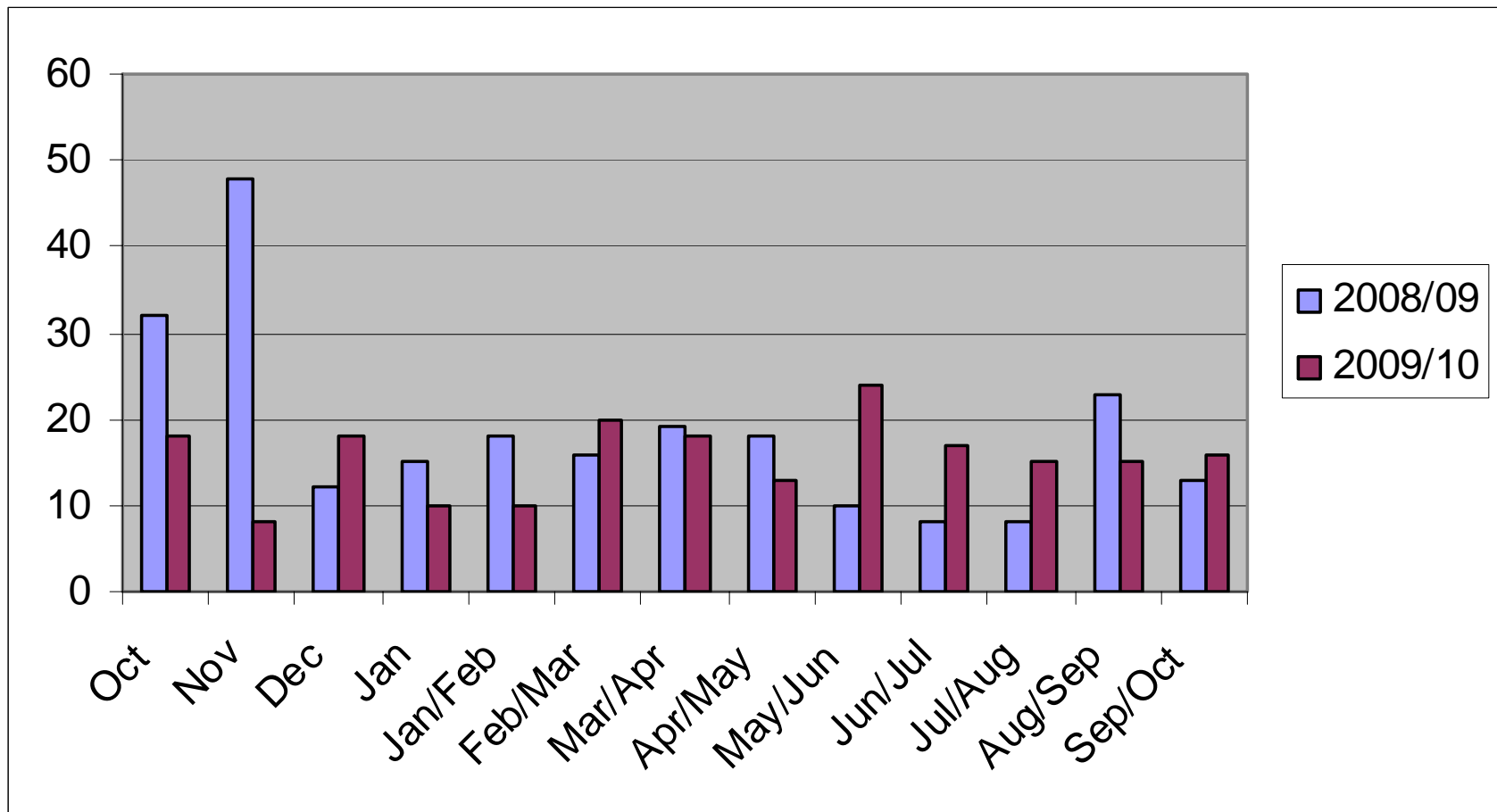
Community Priorities

Parking – Long Street, Atherstone.

- 27 targeted patrols. (20 patrols = 100% agreed Policing activity)
- 30 Fixed Penalty Tickets issued.
- 154 warnings given to drivers.
- Local shops in area visited and posters distributed.
- Press release in Tamworth/Atherstone Herald prior to enforcement process.

Parking – Manor Road, Mancetter.

(footpath near Watham Grange School)

- 19 targeted patrols, (15 patrols = 100% agreed Policing activity)
- No issues found during any visit. (5/10)
- Resident contacted by PCSO and informed of requirements to ensure no obstruction offences are committed

Parking – Coleshill Road, Hartshill. (junction with School Hill)

- 19 checks (15 = 100% agreed Policing activity).
- PCSO has photographed offending HGV's and contacted delivery companies. Transport manager stated that he will send out a team to assess the problems to reduce the risk to drivers and pedestrians. Contact to continue.
- A number of vehicles have been moved on by PCSOs, SNT PCs and Reactive PCs

Hartshill Road Show

On 12th September a Neighbourhood Watch road show was held in Hartshill. The Road show was held in conjunction with the safer neighbourhood team, the Borough Council and North Warwickshire Neighbourhood Watch Association, who provided a variety of personal and home security devices including personal attack alarms, shed alarms and alarmed padlocks. Security and crime prevention advice was given, in respect of bogus callers, home protection measures and road safety for children. Over 100 free security packs were distributed, with a number of people signing up for SMARTWATER. The North Warwickshire Neighbourhood Watch Scheme was actively promoted.

- 26% more visible policing
- Other suggestions included, speed bumps, CCTV, hedge cut back, activities for young people, zero tolerance on pavement parking, pubs closing earlier.

Hartshill Cannabis factory update.

On Tuesday 27 October 2009 an industrial scale cannabis factory was disrupted in Hartshill. This was reported in the January 2010, East forum presentation. The size of the operation led to extensive enquiries, which were finalised at Warwick Crown Court recently, The conclusion of this enquiry were custodial sentences of 6 years and 2 years for those involved.

This successful enquiry was as a direct result of information received from the public.



Warwickshire Police 150plus Programme – Update.

Our current target is to reduce our operating budget by £5.7m in this financial year (10/11) and £13.4m within three years. Additional savings as a result of the Government's Comprehensive Spending Review will further increase the challenges to the service.

Rationalisation at senior management level to take place as a result of restructure.

The Police Authority are considering all options. These include collaboration and partnership working with other forces. A merger with other forces is not under consideration.

No decision regarding work force numbers will be made until the outcome of the Comprehensive Spending Review is known.
