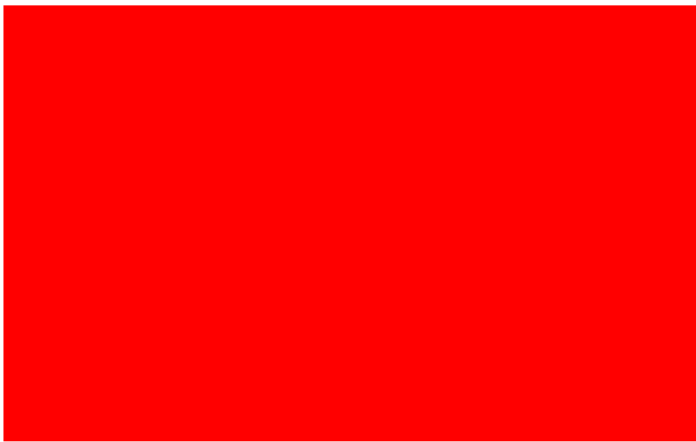
Hi Andrew
