WHEREAS the Council of the Borough of North Warwickshire being the appropriate local planning authority within the meaning of Article 4 of the Town and Country Planning General Development Order, 1977 are satisfied that it is expedient that development of the description set out in the Schedule hereto should not be carried out on land at Mancetter in the County of Warwick comprising in area 99.97 acres or thereabouts and identified by Ordnance Survey field numbers 4709, 5895, 6988, 6315, 7305, 7994, 5961, 4852, 3938, 3523, 5941, 8284, 7975, 8464, 9151, 0444, 0550, 0254, 0159, 9961, 9262, 9465 and 9278, as shown on Ordance Survey Plans SP.3196 and SP.3195 revised July 1957 being the land shown edged red on the plan annexed hereto, unless permission therefor is granted on application made under the Town and Country Planning General Development Order, 1977;

AND WHEREAS the Council are further of the opinion that development of the said description would be prejudicial to the proper planning of their area and would constitute a threat to the amenities of their area and that the provisions of paragraph 3(b) of the said article 4 should apply to this direction;

NOW THEREFORE the said Council in pursuance of the powers conferred upon them by the said article 4 hereby direct that the permission granted by article 3 of the Town and Country Planning General Development Order, 1977 shall not apply to development on the said land of the description set out in the Schedule hereto;

THIS DIRECTION is made in pursuance of the provisions of paragraph 3(b) of the said article 4 and shall remain in force until 9th October, 1979, and will then expire unless it has been approved by the Secretary of State for the Environment before that date.




